Re: School District Income Tax Update For 1998

Five school districts passed an income tax during 1997, three school districts income taxes were revised and four school district income tax was repealed. Combined with the one hundred and twenty school districts that previously had enacted an income tax, the total number of school districts the State of Ohio will be withholding an income tax in 1996 will be one hundred and twenty one. New school district income taxes will be withheld beginning with the first pay period in the 1998 W2 year (pay period 12/20/97 for biweekly delayed payrolls, pay period 01/03/98 for biweekly current payrolls, and pay period 01/31/98 for monthly payrolls).
