Subject: School District Income Tax Updates for 2003

There were four new school district income taxes passed in 2002. No school districts had a rate change and one districts income tax has expired. These school district changes will become effective the first pay period in the 2003 W-2 year (pay period ending 12/28/2002 for the biweekly delayed payrolls, pay period ending 01/11/2003 for biweekly current payrolls and pay period ending 01/31/2003 for the monthly payrolls). The State of Ohio will continue withholding an income tax for one hundred and twenty three school districts.
