Subject: Health Care Rates for the Benefit Period January 1, 2007 thru June 30, 2007

I. HEALTH CARE DEDUCTIONS

To establish health care benefits for new employees or to change existing coverage for the period of December 18, 2006 through March 30, 2007 use the online DAS Benefits Identification form. Once you have completed the form you will fax it to the Base Benefits group at DAS fax number (614) 728-5641. If you have any questions regarding the form or process, please contact the Base Benefits group at (614) 728-5643 or email at DASHRD.Benefits@das.state.oh.us.

Effective April 1, 2007 health care benefits will be administered by the OAKS BenAdmin module. Agencies will receive training in February and March of 2007.

II. HEALTH CARE MAKE-UPS/REFUNDS

The OAKS system will automatically calculate and apply make-ups/refunds up to three months at a time. The "Benefits Make-Up/Refund Form" will be utilized to process all health insurance make-ups that occur outside of three months. Please complete the form and submit to DAS Benefits Administration for approval at 30 E. Broad Street, 28th Floor, or fax to (614) 728-3002. The form is available at the following web site: www.state.oh.us/das/dhr/pdf/benemakeup.pdf.

III. REQUESTING HEALTH INSURANCE REFUNDS OVER THREE MONTHS

The "Benefits Make-Up/Refund Form" should be utilized to request a refund over three months. Please complete the form using the instructions on the back of the form and submit to DAS Benefits Administration for approval. Approved refunds will be forwarded to DAS Payroll Services for processing. Please note that refunds will only be made for an entire month's premium, where two ½ premiums were deducted, or a full share was deducted.
