**Amendment 2**  
**Master Service Agreement**

**This Amendment to the Master Service Agreement**, is between Cincinnati Bell Technology Solutions, Inc ("CBTS" or "Service Provider") having an office at 4600 Montgomery Rd – Suite 400, Cincinnati, Ohio 45212-2600, and the State of Ohio, Department of Administrative Services ("the State"), having its principal place of business at 30 East Broad Street, 40<sup>th</sup> Floor, Columbus, Ohio 43215 (jointly referred hereto as the "Parties"), and it is effective as of the date signed by the State. It amends that certain Master Services Agreement between the Parties dated January 18, 2012.

**Section 1. Recitals.**

- 1.1. WHEREAS**, the Parties entered into that certain Master Service Agreement (the "Agreement") dated January 18, 2012.
- 1.2. NOW THEREFORE**, the Parties intend to make certain changes to the Agreement as described in Section 2 and Section 3 of this Amendment.

**Section 2. Declaration Regarding Terrorist Organization.** The Agreement is amended by deleting Section 3 ("Standard Clauses"), Subsection 3.14 "Declaration Regarding Terrorist Organization ("DMA")" in its entirety.

**Section 3. Agreement – Renewal.** In accordance with Section 6.1 ("Agreement – Renewal"), the State renews the Agreement and the following Service Attachments in the next Biennium, effective July 1, 2013 through June 30, 2015.


