

AMENDMENT 6-B

This document ("Amendment 6-B") is made and entered into as of the date of the last signature hereto by and between Ameritech Custom Business Services, a division of Ameritech Services, Inc., a Delaware corporation as agent and representative of the Ohio Bell Telephone Company, an Ohio corporation and Ameritech Information Systems, Inc., a Delaware Corporation and Ameritech Advanced Data Services of Ohio, Inc., an Ohio corporation (the "Contractor") and the State of Ohio, Department of Administrative Services on behalf of the Bureau of Workers Compensation, (the "State").

Whereas, Contractor and the State entered into a Synchronous Optical Network (SONET) Infrastructure contract dated February 16, 1996 (the "Contract").

Whereas, Contractor and the State entered into an amendment ("Amendment") to add Ameritech Advanced Data Services of Ohio, Inc. ("AADS") as a party to this Contract for the purpose of providing Asynchronous Transfer Mode ("ATM") switching service ("Service") to the State of Ohio.


Whereas, the parties now desire order ATM Service in accordance with the provisions of the Amendment, specifically the ICB pricing contained in Schedule C of the Amendment.


Now, therefore, in consideration of the representations of the parties and the mutual promises and covenants herein contained, Contractor and the State agree as follows:

In witness hereof, the parties have caused this Amendment 6-B to be executed by their duly authorized officers.



- A. The UNI Price assumes Level 1 (75% VBR) QoS Provisioning
 - B. UNI Price Includes SVC Service for H.320 Compressed Video and one PVC for Data
 - C. No additional SCR QoS costs are incurred on the "terminating" UNI for throughput allocated to traffic from "originating" sites mapped to the "terminating" ATM UNI connection.
 - D. Additional PVC costs (\$25.00 for the second PVC and \$5.00 for each subsequent PVC) may be applicable at the "Terminating" ATM UNI connection, pending final network design.
 - E. SCR on the Terminating and Originating Network UNIs will be monitored for "Outbound" PVCs/SVCs only.
 - F. The SUM of the SCR values for all logical connections mapped to a single UNI (terminating or originating") cannot exceed the port speed of the circuit.
