

**AMENDMENT 1
TO
MASTER SERVICE AGREEMENT
BY AND BETWEEN
SPRINT SOLUTIONS, INC. AND
THE STATE OF OHIO, DEPARTMENT OF ADMINISTRATIVE SERVICES
(Sprint Reference No. BSG1111-0297)**

This Amendment, Number 1 ("Amendment") is entered into and between Sprint Solutions, Inc. ("Service Provider") having an office at 12502 Sunrise Valley Drive, Reston, VA 20196 and the State of Ohio, Department of Administrative Services ("the State"), having its principal place of business at 30 East Broad Street, 40th Floor, Columbus, Ohio 43215 (jointly referred hereto as the "Parties") and shall be effective on the date signed by the State ("Effective Date").

Section 1. Recitals.

- 1.1. **WHEREAS**, the Parties entered into that certain Master Service Agreement (the "Agreement") dated December 29, 2011
- 1.2. **NOW THEREFORE**, the Parties intend to make certain changes to the Agreement as described in Section 2 and Section 3 of this Amendment:

Section 2. Declaration Regarding Terrorist Organization. The Agreement is amended by deleting Section 3 ("Standard Clauses"), Subsection 3.14 "Declaration Regarding Terrorist Organization ("DMA")" in its entirety.

Section 3. Agreement – Renewal. In accordance with Section 6.1 ("Agreement – Renewal"), the State renews the Agreement and the following Service Attachments in the next biennium, effective July 1, 2013 through June 30, 2015:

- Service Attachment 1 Wireless Voice and Data Services – 3/15/2012
 - Amendment 1 to SA 1 (Sprint Reference No. BSG1206-0808): Redefine Technology Service Request Terminology – 7/19/2012
- Service Attachment 2 Interexchange (Long Distance) Services – 3/15/2012
- Service Attachment 3 Sprint PCS Telemetry Services – 3/15/2012
