

## AMENDMENT 3 THE MASTER SERVICE AGREEMENT

This is an Amendment to the Master Service Agreement ("MSA") between State of Ohio, The Department of Administrative Services ("the State"), and AT&T Corp. (the "Vendor") ("Contract").

Whereas, the State and AT&T entered Master Service Agreement Contract, titled MASTER SERVICE AGREEMENT by and between AT&T Corp ("the Vendor") and The State of Ohio, Department of Administrative Services ("the State") dated May 20, 2010 ("the Agreement") and further extended the Agreement on March 24, 2011 for the provision of certain Services and;

Whereas, the parties desire to further extend and renew the Agreement for the next biennium.

NOW, THEREFORE, for and in consideration of their mutual promises herein, the parties, mutually agree that the Contract is hereby modified as follows:

1. The following Agreement and all Service Attachments and Amendments related thereto shall be renewed for the next biennium that starts July 1, 2015 and ends June 30, 2017.

## AMENDMENT 3 THE MASTER SERVICE AGREEMENT

2. Service Attachments 2, 3, and 5 will not be renewed.
3. This Amendment shall become effective as of the date of State's signature and shall remain in full force and effect for the term of the Contract. Except as modified by this Amendment, all of the terms and conditions of the Contract shall remain in full force and effect.

The State has requested that AT&T sign this attachment first, and AT&T has agreed to do so. This attachment as signed by AT&T shall be binding upon the State of Ohio signature, and AT&T will begin implementing the attachment when a fully signed copy is returned by the State, provided such fully signed copy is returned to AT&T no more than thirty (30) days after AT&T delivered a signed copy to the State. Further, any and all changes made to the attachment after signature by AT&T shall be void and of no effect, unless and until incorporated into a written amendment to this attachment signed by both Parties, except for changes expressly authorized by the terms of this amendment.
