

**AMENDMENT 1 TO SERVICE ATTACHMENT 7 TO THE MASTER SERVICE AGREEMENT ISDN PRIME SERVICE – SERVICE ATTACHMENT 7 ISDN PRIME SERVICE**

**This is Amendment 1** to the Service Attachment 7 to the Master Service Agreement ISDN Prime Service - Service Attachment 7 ISDN Prime Service between State of Ohio, The Department of Administrative Services ("the State"), and AT&T Corp. ("Vendor" or "AT&T") ("Contract").

**Applicable AT&T Affiliate and State:** (hereinafter "AT&T") The Ohio Bell Telephone Company d/b/a AT&T Ohio


WHEREAS, AT&T and the State entered into a Contract last signed by the State on June 27, 2011 for the provision of ISDN Prime Service; and AT&T and the State hereby agree to modify the Contract as follows:

1. On page 3 in the first paragraph of Contract, the State and AT&T agree to change AT&T contracting party name to AT&T Corp. on behalf of the AT&T entity authorized to provide Services hereunder: The Ohio Bell Telephone Company d/b/a AT&T Ohio ("Vendor" or "AT&T").
2. Page 19 of Contract shall be amended to change the AT&T Federal Tax ID below the AT&T signature block to:  
Federal Tax ID: 34-0436390.

3. This Amendment shall become effective as of the date of State's signature and shall remain in full force and effect for the term of the Contract. Except as modified by this Amendment, all of the terms and conditions of the Contract shall remain in full force and effect.

The State has requested that AT&T sign this attachment first, and AT&T has agreed to do so. This attachment as signed by AT&T shall be binding upon the State of Ohio signature and AT&T will begin implementing the attachment when a fully signed copy is returned by the State, provided such fully signed copy is returned to AT&T no more than thirty (30) days after AT&T delivered a signed copy to the State. Further, any and all changes made to the attachment after signature by AT&T shall be void and of no effect, unless and until incorporated into a written amendment to this attachment signed by both Parties, except for changes expressly authorized by the terms of this amendment.
