

## WILMAPC Provider Panel Quick Reference

### What is WILMAPC?

The Workplace Injury Labor Management Approved Provider Committee (WILMAPC) was created specifically to administer the Provider Panel which is a list of eligible approving providers for Salary Continuation and Occupational Injury workers compensation claims. Salary continuation is a benefit offered by the State of Ohio for employees that are injured at work, providing them with uninterrupted pay (100%) for up to 480 hours. Occupational Injury Leave is a benefit offered to State of Ohio employees at specific agencies who are injured on the job as a direct result of a ward of the State (inmate, client, patient, resident, youth or student). ### Who is on the WILMAPC Provider Panel?

The WILMAPC Provider Panel is a panel of providers that are certified with the Ohio Bureau of Workers' Compensation (BWC) and are eligible to be the approving provider for a Salary Continuation (SC) or Occupational Injury Leave (OIL) claim.

Eligibility extends only to the 7 types of Provider of Record (POR) that are recognized by BWC. These types are: Medical Doctors, Doctors of Osteopathic Medicine, Chiropractors, Podiatrists, Dentists, Psychologists, and Mechanotherapists. Physician Assistants, RNs, LPNs, etc. are not recognized as approving providers and cannot certify disability on a claim in this program.

The WILMAPC Provider Panel is not the same as the BWC certified provider panel. WILMAPC Panel providers not only have to be BWC certified, but they must meet a workers' compensation claim volume requirement in order to be eligible to join the Provider Panel. Once a provider is on the panel, he/she can become the approving provider in a claim and is also eligible to certify disability within the program (SC or OIL claims).

### How to utilize the WILMAPC Provider Panel:

In order to take full advantage of the Salary Continuation (SC) or Occupational Injury Leave (OIL) benefits available to injured State of Ohio agency employees, injured workers (IW) must adhere to the requirements for filing SC or OIL claims. The IW must be diagnosed and treated by a WILMAPC approved provider in order for their claim to be approved for SC or OIL.
