14-foot aluminum boat and trailer among vehicles on sale at state auction



COLUMBUS (June 2, 2017) – A 14-foot 1989 Sea Nymph Aluminum V Boat and trailer and 2014 four-door Dodge Durango SXT with four-wheel drive will be among approximately 230 vehicles up for bid at the next state surplus vehicle auction scheduled for Saturday, June 10.

The auction will be held at the Ohio Department of Administrative Services, General Services Division headquarters, 4200 Surface Road, Columbus, 43228. The gate opens at 8 a.m. and the auction begins at 9 a.m. The lot will remain open until 5 p.m. on the day of the auction.

The sale also will feature a 2004 Suzuki GZ250 motorcycle and 2003 Honda CRF150 motorcycle as well as a variety of other cars, trucks, vans and other vehicles.

Vehicles may be inspected between 8 a.m. and 3 p.m. Monday, June 5 through Friday, June 9. Vehicles may be started only between 8 a.m. and 2:45 p.m. June 9.

All vehicles are sold “as-is” with no warranties. Purchasers with purchases of less than \$25,000 will be required to pay the entire amount due on the date of the sale. Purchasers with total purchases of \$25,000 or more shall provide no less than 25 percent of the total sale the day of the auction, with the balance due to the auctioneer no later than noon on the first business day following the auction. Cash, credit and debit cards (Discover, MasterCard and Visa) are accepted. There is a 3 percent service fee on all credit and debit card transactions. Temporary tags are no longer available at state surplus vehicle auctions.

Surplus property auctions provide the general public an opportunity to purchase quality goods at reduced prices and enable the state to recoup a portion of its initial investment. Miscellaneous property and vehicle auctions generated more than \$6.3 million during Fiscal Year 2016.

Public auctions are the last step in the state's surplus program. State agencies declare property as surplus because it is either damaged or at the end of its life cycle for government use. In addition, property may include items seized by law enforcement officials as well as items surrendered to the TSA by airline passengers during security screening. The property is then made available to other state agencies, state higher education facilities, tax-supported agencies, municipal corporations and other political subdivisions of the state, including public schools. Remaining property is sold at the public auctions.
