

NOTICE OF PUBLIC HEARING

NOTE ON ELECTRONIC HEARING: To reduce the spread of the novel coronavirus (the virus that causes COVID-19) and pursuant to section 12 of Am. Sub. H.B. No. 197, the Department of Administrative Services is conducting this hearing virtually through electronic means. During the hearing, any person affected by the proposed rule actions who wishes to appear and be heard **must participate electronically**. THE DEPARTMENT OF ADMINISTRATIVE SERVICES (DAS), pursuant to Chapter 119 of the Ohio Revised Code, hereby gives notice that a public hearing will be conducted for the purpose of considering the rescission of the following rules contained in the Ohio Administrative Code.

All interested persons affected by the proposed actions may be heard by oral or written testimony.

The following rules are being rescinded:

- 123:2-15-02 Bid notifications and specifications concerning minority business enterprises.**
- 123:2-15-03 Minority set aside review board established.**
- 123:2-15-04 Application to the minority set aside review board.**
- 123:2-15-05 Minority set aside review board procedures for emergency contracts.**
- 123:2-15-06 Minority set aside review board notice of meetings.**

These rules are being rescinded because the authorizing legislation has since been repealed. The minority set aside review board was created by former R.C. 123.151(C)(4), and DAS was authorized to adopt rules concerning the board by former R.C. 123.151(C)(5). These provisions were repealed in 2004 by HB 216 of the 125th General Assembly, and the Minority Set Aside Review Board no longer exists.
