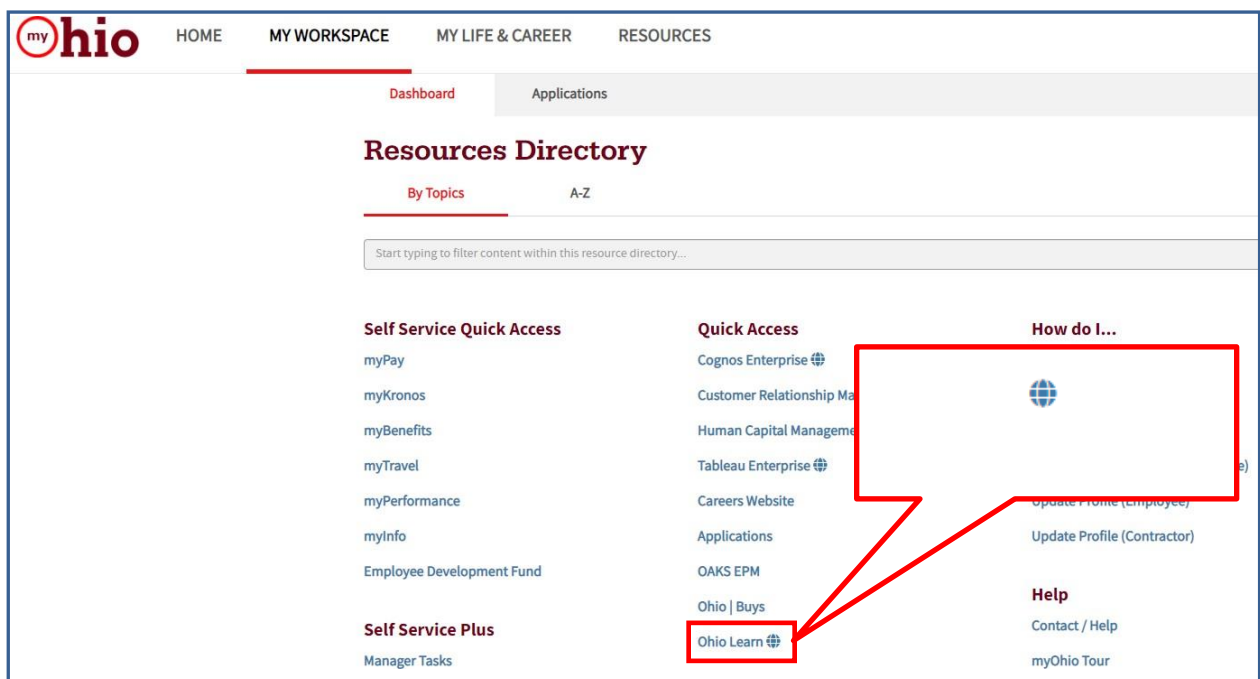
## Accessing the Lead Ohio Learning Plan via Ohio Learn

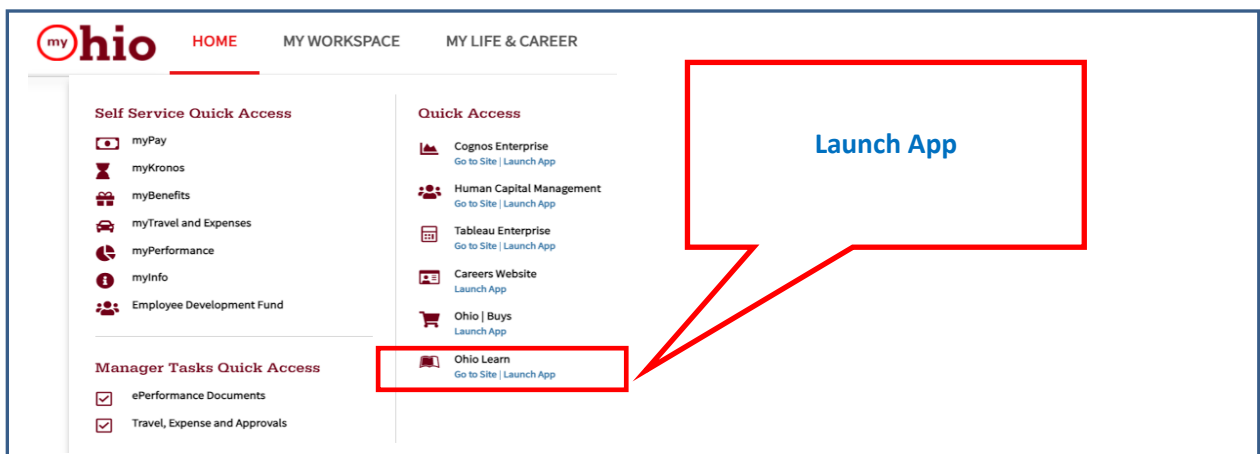
### Launching Ohio Learn

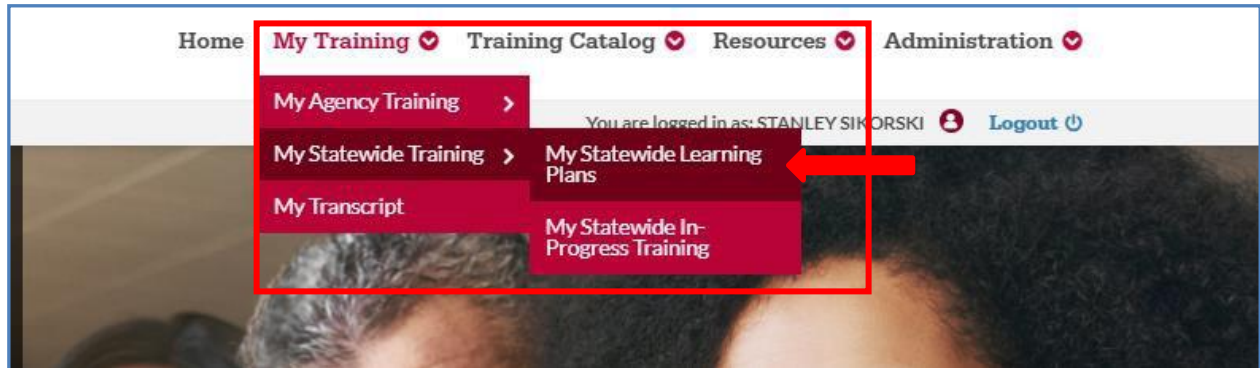

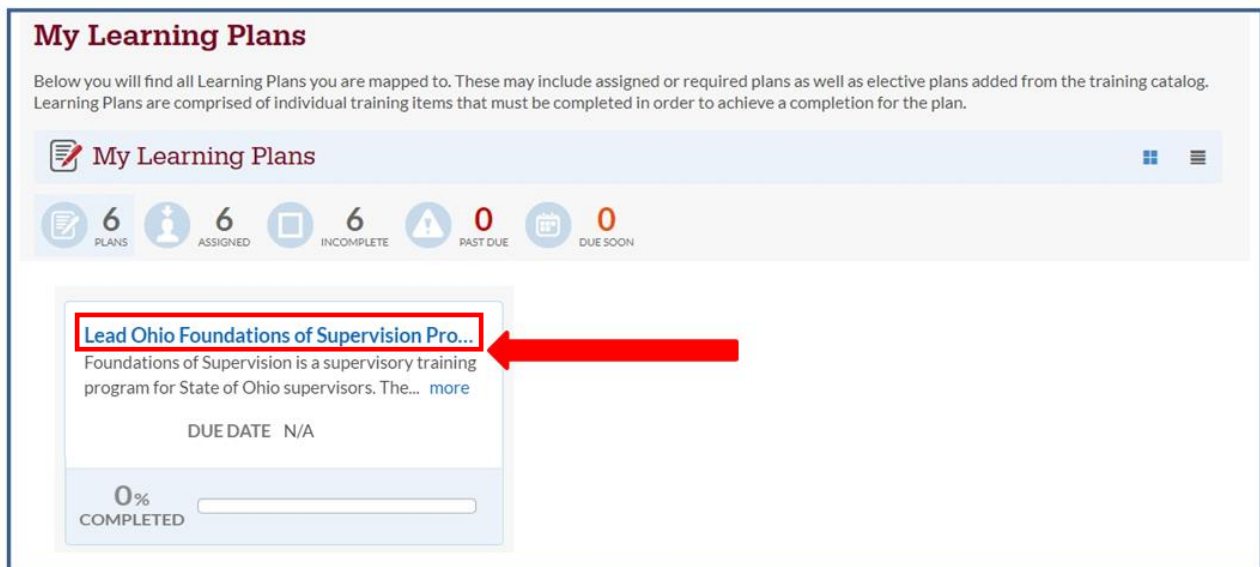


## Accessing My Statewide Training

1. On the menu at the top of the page, select **My Training**, hover over **My Statewide Training** and then click on **My Statewide Learning Plans**. The **Lead Ohio Foundations of Supervision** Learning Plan will be displayed.



2. **CLICK** the title of the Learning Plan to access the **Lead Ohio Foundations of Supervision Program**.



3. The **Lead Ohio – Introduction to Foundations of Supervision** Learning Program is currently available to complete in a virtual instructor-led (VILT) or eLearning format. All courses within the program will be listed.
  - A. **Lead Ohio – Introduction to Foundations of Supervision (for eLearning only)**  
**(NOTE: for eLearning only)** This course is designed to familiarize learners with the eLearning version of the program and requirements for completion. This module is a prerequisite to launch any eLearning courses.
  - B. **DISC Assessment** – The DISC Assessment is a prerequisite to complete the Lead Ohio Foundations of Supervision program. It must be completed prior to registering for a virtual instructor-led session or launching the eLearning module.
  - C. **Lead Ohio - Introduction to DISC** – Each required course in the program is listed. The user must complete each course title to successfully complete the Foundations of Supervision program. You have the option to complete some courses as instructor-led and some as eLearning. All modules within an eLearning course must be completed to receive credit.

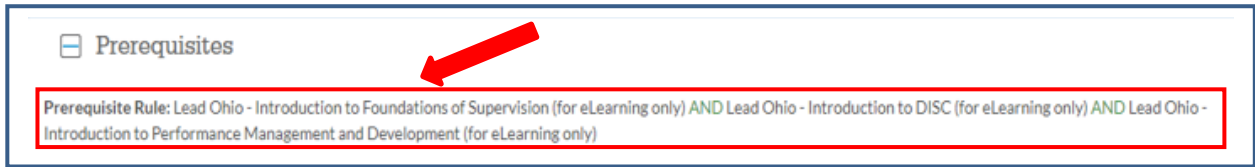

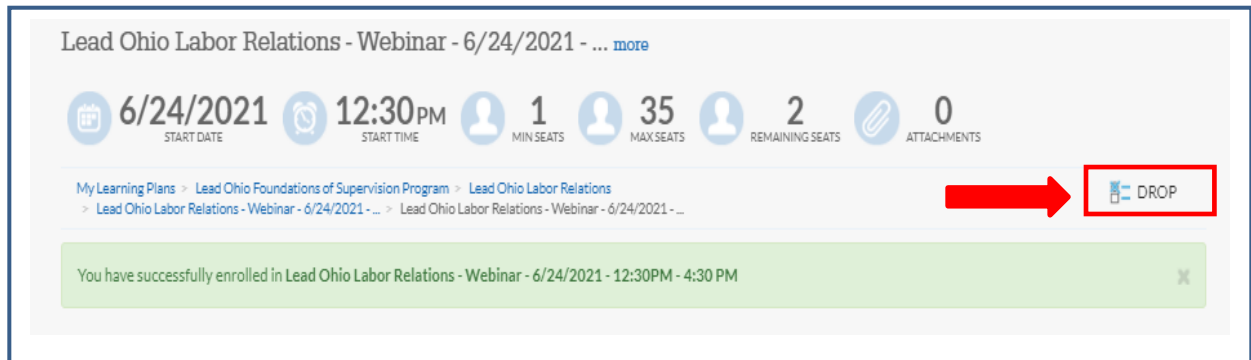
