

**AMENDMENT 1 TO SERVICE ATTACHMENT 2  
TO THE MASTER SERVICE AGREEMENT**

This is **Amendment 1** to the Service Attachment 2 to the Master Service Agreement between the State of Ohio, The Department of Administrative Services ("the State"), and Agile Network Builders, LLC. ("Service Provider")

**Customer Name:** State of Ohio, The Department of Administrative Services

WHEREAS, The Service Provider and the State entered into a Contract last signed by the State on March 9, 2012 for the provision of Agile Ohio Network Connect Services; and the Service Provider and the State hereby agree to modify the Contract as follows:

1. Page 5 of the Contract shall be amended to add the following option below section 6.



**6.1 One Time Up Front Payment Option**

For Subscribing Entities who provide a one-time up front payment, the Service Provider will recalculate the monthly rate to reduce monthly recurring charge(s). The aggregate cost to the subscribing entity under this option cannot exceed the aggregate cost as specified in section 6 above.

2. This Amendment shall become effective as of the date of State's signature and shall remain in full force and effect for the term of the Contract. Except as modified by this Amendment, all of the terms and conditions of the Contract shall remain in full force and effect.

The State has requested that the Service Provider sign the attachment first, and the Service Provider has agreed to do so. This attachment as signed by the Service Provider shall be binding upon the State of Ohio signature and the Service Provider will begin implementing the attachment when a fully signed copy is returned by the State, provided such fully signed copy is returned to the Service Provider no more than thirty (30) days after the Service Provider delivered a signed copy to the State. Further, any and all changes made to the attachment after signature by the Service Provider shall be void and of no effect unless and until incorporated into a written amendment to this attachment signed by both Parties, except for changes expressly authorized by the terms of this amendment.

In Witness Whereof, the Parties have executed this Amendment, which is effective on the date the State's duly authorized representative signs it on behalf of the State, ("Effective Date").
