

**MASTER CLOUD SERVICE AGREEMENT  
AMENDMENT NUMBER THREE**

**THIS AMENDMENT NUMBER THREE** (the "Amendment") is between the State of Ohio, Department of Administrative Services (the "State") and Granicus, LLC, formerly GovDelivery, Inc. (the "Service Provider"). This Amendment changes the terms of the Master Cloud Service Agreement (MCSA0031).

WHEREAS the State and the Contractor entered into the Contract on September 9, 2016;

WHEREAS, the State and the Contractor determined that a Contract Amendment is necessary to address certain revisions to the Contract;

NOW, THEREFORE, The Contract is amended to formally change the Contractor's name from GovDelivery, Inc. to Granicus, LLC.

This Amendment shall become effective as of the date of State's signature and shall remain in full force and effect for the term of the Contract. Except as modified by this Amendment, all of the terms and conditions of the MCSA shall remain in full force and effect.

Except as expressly modified in this Amendment, all the terms of the Contract remain unaffected and unchanged by this Amendment.

- 4) Documentation of these changes has been filed with the State.

In consideration of these facts, the parties agree that:

- 1) The Contract is amended by substituting the name Granicus, LLC for the name GovDelivery, Inc. wherever those names may appear in the Contract.
- 2) Each party has executed this Agreement as of the day and year first written above.
